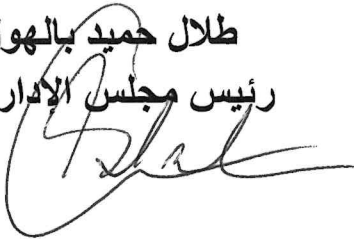

## **Decision on Information related to the United Arab Emirates trusted list**

## Introduction

Pursuant to the Definition of UAE Trusted List “a list prepared and published by TDRA, identifying TSPs, QTSPs, their services and Data relating thereto. It also checks the status of a License, and the extent of compliance with this Decree-Law, Executive Order, and the decisions issued by TDRA in implementation thereof;”

And in reference to Article 34(1) and Article 34(3) of the Executive Regulation No. (28) of 2023, the Telecommunications and Digital Government Regulatory Authority (TDRA) makes available to the public, through a secure channel to an authenticated web server, the UAE trusted list (TL), in a signed or sealed XML machine-processable form suitable for automated processing in compliance with the specifications pursuant to the “Resolution No. (54) of 2023 on the technical specifications and formats relating to the United Arab Emirates trusted list”.

The authenticity and integrity of the UAE TL shall be verified by relying parties prior to any use.

The present publication details below where this UAE TL is made available (hereafter the ‘UAE TL location’) and which certificates support the signing/sealing of the UAE TL (hereafter the ‘UAE TL-signing certificates’). Further details on the mechanism in Section 2 can be found at <https://uaetl.trustservices.gov.ae/tools/uaetl/pivot-uaetl-explanation.html>.

### 1. Initial state at the date of publication of the present document

At the date of publication of the present document, the following applies:

- The *UAE TL location* is the following URL: <https://uri.trustservices.gov.ae/uae-trusted-list/UAE-TL.xml>.
- The authenticity and integrity of the UAE TL are ensured through an electronic signature (or electronic seal when applicable) supported by one of the *UAE TL-signing certificates* represented in PEM format (‘Privacy-Enhanced Mail’ file format) in the Annex, and that can be authenticated using the following digest information:

## 2. Future change(s) of the UAE TL location or UAE TL-signing certificates

### 2.1. Introduction

From the date of publication of the present information, the UAE TL shall include:

- The UAE TL location together with the PEM representation of the UAE TL-signing certificates as provided in the Annex.
- As the first part of the information regarding the underlying scheme (i.e. the '<SchemeInformationURI>'), in reverse chronological order – that is, showing the most recent publication first – the list of:
  - zero or more URLs where the archived preceding pivot UAE TLs are published, back until and followed by
  - the URL of the latest relevant publication in the Official Gazette of the UAE related to the UAE TL.

### 2.2. Standard procedure

A future change to the UAE TL location or the UAE TL-signing certificates shall be reflected in the publication of a new instance of the UAE TL which will include a new UAE TL location or a modified set of UAE TL-signing certificates for relying parties to use when authenticating the UAE TL. Such a new instance of the UAE TL announcing a new UAE TL location or UAE TL-signing certificates is hereafter referred to as a 'pivot UAE TL', as it represents a pivot point in the historical values of the UAE TL location and the UAE TL-signing certificates. A pivot UAE TL can announce a change in the UAE TL location, a change of the UAE TL-signing certificates, or both.

Starting at the date of issuance of a pivot UAE TL in which this new information is first published, the UAE TL location and UAE TL-signing certificates may be used by relying parties to locate and authenticate the UAE TL in replacement of the formerly issued UAE TL location and UAE TL-signing certificates. The TDRA will also ensure that the formerly issued UAE TL location and UAE TL-signing certificates can still be used to locate and authenticate the UAE TL until 15 days after the issuance of the pivot UAE TL announcing the new UAE TL location or UAE TL-signing certificates. This provides a transition period for relying parties to consume the new information at their most convenient time within this period.

### **2.3. Exceptional procedure**

As an alternative to the mechanism explained in section '2.2. Standard procedure', a new publication in the Official Gazette of the UAE by the TDRA may however abruptly change the UAE TL location, the UAE TL-signing certificates, or the duration of the transition period, for instance as a temporary response to an emergency situation requiring the immediate replacement of all UAE TL-signing certificates.

## **Publication**

This decision shall be effective from the date of its issuance and shall be published in the Official Gazette.
