Organized by TDRA, UAE hosts 54th meeting of ATICM Executive Bureau

The United Arab Emirates, represented by the Telecommunications and Digital Government Regulatory Authority (TDRA), hosted the 54th meeting of the Executive Bureau of the Arab Telecommunications and Information Council of Ministers (ATICM) on 24 July 2024 in Dubai to discuss the results of the 54th Session of the Arab Permanent Postal Commission (APPC) and the 53rd Arab ICT Permanent Committee meeting. The meeting was chaired by TDRA's Director-General H.E. Eng. Majed Sultan Al-Mesmar, in the presence of representatives of Arab telecom ministers and the heads of delegates from the Arab states.

UAE chairs 53rd Arab ICT Permanent Committee

The city of Dubai in UAE saw the 53rd session of the Arab ICT Permanent Committee on July 22, 2024 for two days. The UAE-led meeting was represented by H.E. Eng. Mohammed al-Ramsi, TDRA's Deputy Director-General of the Telecommunications Sector. Delegates from various Arab states, the Technical Secretariat of the Council of Arab Ministers of Communications and Information (CAMCI-TS), as well as representatives of a number of bodies and organizations with observer status, including the ITU Arab Regional Office, took part in the meeting.

The Telecommunications and Digital Government Regulatory Authority (TDRA) has launched the Knowledge Hub program designed to train employees at the Federal Competitiveness and Statistics Center (FCSC) with the aim of equipping them with skills and knowledge that are in line with the objectives and requirements of the FCSC.

The program includes nine training tracks that combine self-paced learning with interactive learning for several data-related topics and ways to analyze and utilize data, while harnessing AI to support the data revolution, in addition to competitiveness-enhancing programs. Tourists and visitors can claim refund on VAT paid on purchases they made during their stay in the UAE. Recovery of payment will be done through a fully integrated electronic system which connects retailers registered in the 'Tax Refund for Tourists Scheme' with all ports of entry and exit from the UAE.
