Service steps

- Step 1** → Register using UAE Pass
- Step 2** → Fill in the service application form
- Step 3** → Attach all required documents
- Step 4** → Review the application by specialized team at the Authority
- Step 5** → Obtain a customs release permit

Required Documents	<p><u>Documents required from individuals:</u></p> <ul style="list-style-type: none"> - Customs documents for the shipment - Technical specifications of the devices <p><u>Documents required from business:</u></p> <ul style="list-style-type: none"> - The device approved in the company account - Customs declaration - Bill of lading - Device specifications - Shipping lists or invoices <p>As for business wishing to participate in exhibitions held within the country, whether they are business from outside the country or inside the country, they must adhere to the following:</p> <ul style="list-style-type: none"> - A letter from the organizing body indicating that the concerned company is participating in the exhibition and specifying the name of the exhibition, its location, its date, and the company's platform number - A letter of undertaking from the company addressed to the Authority stating that the devices will be returned to their source after the end of the exhibition.
