### About the Service/Feature

This service aims to issue licenses to trust service providers and qualified trust service providers in the United Arab Emirates.

### Service steps

- Step 1** → Login using the UAE Pass
- Step 2** → Fill in the application form and attach all required documents
- Step 3** → Pay the application fee through the available payment channels
- Step 4** → The application will be reviewed by a specialized team at the Authority
- Step 5** → Pay the approved Trust Services fees
- Step 6** → Obtain the license
