Apply for a radio authorization for ship or boat or shore to ship

### Service steps

- Step 1** → Log in using your UAEPass account.
- Step 2** → Fill in and submit the application for frequency spectrum authorization along with the required documents
- Step 3** → Payment of spectrum fees through the specified payment channels in accordance with TDRA spectrum fees regulations
- Step 4** → Collect the frequency spectrum authorization issued by TDRA online

<p><b>About</b></p>	<p><b>Maritime Ship</b></p> <p>The Ship Radio License required as a mandatory document to be carried onboard, this license authorizes the installation and use of maritime radio and associated equipment, on a named ship, subject to applicable license conditions. The ship must be registered in the UAE with the Federal Maritime Authority (FTA). A Ship Radio License also assigns the ship a radio identity in the form of its call sign and MMSI. TDRA Regulations on Maritime Radio System can be referred for details.</p> <p><b>Fishing Boats</b></p> <p>A special small boat authorization only issued to boats registered with the UAE Ministry of climate change and environment and authorizes the installation and use of maritime radio and associated equipment, on a named trawler, subject to applicable authorization conditions. TDRA Regulations on Maritime Radio System can be referred for details.</p> <p><b>Shore to Ship</b></p> <p>This authorization allows use of authorized radio station by entities e.g. shipping agents, port authorities, etc.. to communicate with Vessels to:</p> <ul style="list-style-type: none"> <li>Communicate on Commercial matters using an assigned maritime channel.</li> <li>Communicate on ports and harbors to support port operations and ship movement.</li> <li>Communicate for search and rescue purpose.</li> </ul> <p>TDRA Regulations on Maritime Radio System can be referred for details.</p> <p><b>Radio navigation</b></p> <p>Automatic Identification System (AIS) is a data system whereby ships transmit information relating to the vessel to other AIS stations repetitively and also on interrogation by other AIS stations including shore stations, thereby making themselves known to other ships and shore stations. TDRA Regulations on Maritime Radio System can be referred for details.</p> <p><b>PMR on-board ship</b></p> <p>a PMR Spectrum Authorization issued to PMR networks requiring dedicated frequency other than maritime and higher power levels than allowed for on board ship.
